1. Nominators complete this form and are responsible for verifying the accuracy of the information submitted on this form. (Please do not write by hand.)
2. A selection committee reviews and rates the forms, then selects the inductee(s).
3. All nominators and nominees are notified in writing.
4. A public award ceremony and reception is planned, inductees become permanent members of the Hall of Fame of Delaware Women.
