Notice of Special Election for the Office of State Representative for State Representative District 20 to fill the vacancy created by the resignation of Stell Parker Selby, and to hold office for the remainder of the term.

Date of Special Election: Tuesday, August 5, 2025

Voting Requirements:

- You must be a Delaware registered voter, 18 years of age or older by the date of the Special Election, residing in **State Representative District 20**.
 - Eligible voters may vote regardless of political party affiliation. Check if you are registered to vote in Representative District 20 at https://ivote.de.gov.
- The **Voter Registration Deadline** for new voters residing in State Representative District 20 to register to vote in order to vote in the Special Election is **Saturday**, **July 26**, **2025**.
- You will be asked to present identification before you vote at your assigned Polling Place on Election Day.
- If you do not present identification, and you are at your assigned polling place on Special Election Day, Election Officers will verify your voter registration information. When your voter registration is confirmed, you will be permitted to vote after completing an Affidavit of Affirmation of Voter Identity.

Voting at Your Assigned Polling Place:

Polls are open from 7AM – 8PM on Special Election Day, August 5, 2025. Your assigned Polling Place is listed on your Polling Place Card. You may call the Department of Elections, Sussex County office at 302-856-5367 or visit https://gis.elections.delaware.gov to find your polling place.
